#### TRIP NEWS

The projected informal trip on the New York & Long Branch in August has had to be cancelled, because the Trenton-Red Bank gas car now operates Mondays through Fridays only. In its place, tentative plans have been made for a trip to various points of interest in New Jersey by privately owned automobiles on a Saturday or Sunday early in August. Details on this will be announced by the Trip Committee shortly.

Also in the works is a fall trip on the Reading and Jersey Central in October. have given up passenger service.

## DU NOT TO WIN FRIENDS NO INFLUENCE PROPLE

Within a week of bus substitution on the West Chater line, Philadelphia Suburban Transportation Company asked for a fare incress to 15 cents cash, 3 tokens for a cents. The Pennsylvenia PUU has approved, and the rate will go into effect My 16. CINDERS' political editor believe that the nearness of the two events will considerably strengthen public opposition to any future hus substitutions.

Mcanuhile, PTC is having its own troubles. The directors declared a dividend of approximately 5%, to be paid at the end of this north. Some stock holders protested that the dividend should have been larger, while the city opposes any dividend, claiming the money should be spent for new equipment. The dividend, the mayor stated, could be used for a down payment on 128 busses. The city is threatening court action, and has asked for a PUC investigation. CIMPERS' financial editor advises any readers who are interested in buying securities yielding a dividend that can be paid without protest not to buy PTC common. An unknown purchaser, however, is buying large pieces of it; newspaper speculation is that the buyer is National City Lines.

## MISCELLANEOUS NEWS

PRSL has inaugurated one-day Sunday excursions to Atlantic City for \$2.95; last Sunday, the first day of operation, over 850 cash customers took advantage of the low round-trip rate.

Clinchfield and Missouri-Illinois

Raritan River has ordered diesels; the road will be probably become an exsteam road about October.

The largest RDC order yet - 55 -has been given to Budd's by Boston & Maine. This will be the end of steam operation and the end of the road's open platform coaches.

The ICC order restricting piggyback operations has been rescinded, and the Eastern trunk lines are jumping in with both fect. However, there will be no intrastate piggyback operations in Ponnsylvania vatil the FUC approves.
